## **Reduced Fee Facility for Freeze Memberships:**

### **Eligibility**

A Gold or a Platinum Member may be treated as an Freeze Member when he/she goes out of the country for minimum one month, provided a written Application/ Intimation on the prescribed format is given to the Accounts Department prior to his/her departure along with copy of the Air Ticket, relevant Visa and all supporting evidences as proof of travel.

A Member, who fails to give notice of departure in writing, shall be liable to pay full monthly subscriptions until such notice in a manner as prescribed above has been given. No compensation for the benefit lost due to such delayed intimation will be available to any member.

Club will have the right to require the applicant member for furnishing further supporting documents/proofs to establish his/her eligibility under this policy whenever and wherever considered necessary.

The facility will be granted at the sole discretion of the Club and in any circumstances the members will have no right to raise objection or request any explanation on acceptance or rejection of any such application.

### **Benefit**

The member on the Freeze List will be charged a concessional fee at the rate of 50% of prevalent Monthly Subscription for the period of his / her stay abroad.

The said rate/percentage may be changed by the Board of Governors/Committee from time to time as and when required by the circumstances through a circular.

## **Constraints**

The family members of a Platinum Member, while being on the Freeze List, will not be permitted to enter or use the Club facilities from the day of availing this benefit till the end date of this facility and restoration of Club Facilities as per procedure laid down in the relevant clause of this policy.

The payment of such monthly reduced fee must be within given due time as there will be no relaxation available in due date for such members on ground of their absence and/or due to any other reason.

The benefit under this policy will be available from the 1<sup>st</sup> of the following month of the date of intimation. No pro rata based benefit will be allowed on intimations received during the month.

## **Restoration of Club Facilities**

For restoration of all Club Facilities, restricted under this policy, a Member on the Freeze List will have to give notice on arrival in writing to the Accounts Department alongwith copy of exit entry on passport as proof of stay abroad. The Club Facilities will be restored within 24 to 48 hours upon receipt of aforementioned notice, after completion of official formalities.

If restoration is requested by such member on or before 15<sup>th</sup> day of that month, full subscription fee for that month will have to be paid either concessional payment has been paid or not as on the date of request. In other case where concessional fee has already been paid and request is submitted after 15<sup>th</sup> day of that month, full fee will be charged from the following month.
